Volunteer Program Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 20____,

By _____ (the "Volunteer") in favor of BRIDGES TO PROSPERITY, INC., a nonprofit group organized and existing under the laws of the State of Virginia, USA, its affiliates organizations in other nations, its directors, offices, employees and agents (collectively, "B2P").

I, the Volunteer, desire to work as a Volunteer and engage in the activities related to being a volunteer with B2P. I understand that the activities may include but are not limited to , traveling to and from other countries, traveling within these countries, consuming food and living in accommodations available or provided in the foreign country(ies), researching bridge sites, constructing bridges, inspecting completed bridges and other activities related to the program.

I hereby freely and voluntarily, without duress, execute the Release under the following terms.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless B2P and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my work for B2P.

I understand and acknowledge that this Release discharges B2P from any liability or claim that I, the Volunteer, may have against B2P with respect to any bodily injury, personal injury, illness, death or property damage that may result from my participation in any B2P project. I understand that B2P does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance, in the event of injury, illness, death or property damage (see #2 below).

2. Insurance: I, the Volunteer, understand that, except as otherwise agreed to by B2P in writing; B2P does not carry or maintain health, medical or disability insurance coverage for any volunteer. B2P's Board of Directors requires all volunteers to have appropriate travel insurance, and to fully comply at their own expense with all Center for Disease Control and US Department of State travel recommendations. Insurance is paid for by the Volunteer.

3. Medical Treatment: Except as otherwise agreed to by B2P in writing, I hereby release and forever discharge B2P from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with B2P.

4. Assumption of the Risk: I understand that my time with B2P may include activities that may be hazardous to me, including, but not limited to, construction activities, working in & around rivers/gorges, and local transportation to and from remote work sites. I recognize and understand that my time with B2P may, in some situations, involve inherently dangerous activities. I also understand that in addition to consuming local foods, being subject to increased disease risk, and living in substandard accommodations which are available in the country(ies) visited, I may be traveling to and from locations which pose risks from terrorism, war, insurrection or criminal activities. I also understand that, in order to protect its volunteers in all countries around the world, it is B2P's policy that it will not pay ransom or make any other payments in order to secure the release of hostages.

I hereby expressly and specifically assume the risk of injury or harm in these activities and release B2P from all liability for injury, illness, and death or property damage resulting from the activities of my time with B2P.

5. Photographic Release: I grant and convey unto B2P all right, title, and interest in any and all photographic images and video or audio recording made by B2P during my work for B2P, including but not limited to any royalties, proceeds, or other benefits derived from such photographs or recording. I also grant and convey unto B2P free use of any photographic images I have taken and forwarded to B2P by email or other means.

6. Other: I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Virginia in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Virginia. I agree that in the event that any cause or provision of the Release shall be held invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
